PLAYING REGULATIONS

PART A: SAFETY REQUIREMENTS

Ontario Physical Activity Safety Standards in Education (OPASSE)

All coaches must review and follow the most recent copy of the [OPASSE GUIDELINES](#) for the sport they are coaching (under Secondary, Interschool)

Concussion Awareness and Safety

In accordance with Policy/Program Memorandum No. 158, the TDCAA will follow and support the mandates of Rowan's Law. The following must occur annually, at the commencement of the athletic season:

a) coaches must complete the on-line [TDCAA Coaches Concussion Code of Conduct](#)

b) coaches will have student athletes review and follow a Concussion Code of Conduct:

In the event of a suspected concussion convenors, coaches, and student athletes must follow an established Return to Play Protocol.

Note: TCDSB has established [Concussion Return to Play Protocols](#) for its students and coaches to follow. Non TCDSB participants should reference their Board's or [OPHEA's Concussion Protocols](#)

Coaches may find it useful to have a recognized [Sport Concussion Recognition Tool](#) with them for practices and competition.

Supervision – Visiting Teams

Each school along with the coach should be aware of the local policy in each school regarding visitors.

In situations where teams are specifically bringing fans (fan bus) appropriate supervision from all participating schools that does not include the team coach(es) must be provided. Communication with school administration of participating schools is prudent in these situations.

PART B: FROM TDCAA CONSTITUTION

TDCAA Tackle Football is an official TDCAA activity. Football follows OPHEA/OPASSE OFSAA, and the Canadian Amateur Football playing regulations.

REGISTRATION

Schools must register for Football at the designated time. A school may withdraw its team before distribution of the final schedule. The school will be charged only the \$ 25.00 registration fee. A school who withdraws its team after the schedule has been distributed will assume the following actions:

- automatic \$100 fine
- automatically ineligible for competition in football the following year. (This can be appealed to the TDCAA executive.)

ELIGIBILITY/TRANSFERS

Eligible Athletes must satisfy the By-Laws and the Standing Rules as per the TDCAA Constitution.

- All eligibility shall be completed electronically through Athletic Eligibility List System (HUB) which is coordinated through the OFSAA office. Athletic Directors have the code for their schools to access HUB.
- Eligibility must be completed before the first league game. (It is recommended that registration be completed before first practice). In a single day meet or tournament format , eligibility must be filed at least three days prior to the meet or tournament.
- All coaches and athletes must be included on the HUB site.
- Approved transfers are included on the eligibility form. Athletes who have not been approved must not be included until the athlete has been approved.

- All students who transfer into your school (excluding Grade 9-first year of high school) are ineligible for competition for a period of twelve months from the date of transfer. To become eligible, transfer students must complete the “TRANSFER APPEAL FORM” fully and forward to the TDCAA Transfer Chairperson (Lorraine Kelly – Senator O’Connor or Tavia Ferreira – St. John Paul II). An athlete awaiting Transfer Appeal decision is ineligible to play in any games (league or exhibition or tournament). This athlete may practice with the team until the transfer has been approved and the athletic director has been notified.
- An student who transfers into your school in second semester is ineligible to compete in winter sports (Alpine Skiing; Snowboarding; Swimming; Jr & Sr. Girls’ Volleyball, Boys’ & Girls’ Hockey, and Jr. & Sr. Boys’ Basketball even if their transfer is approved.)
- An athlete whose transfer is denied has the right to appeal the decision to the TDCAA Transfer Appeal Board.

ELIGIBILITY/AGE

- Open Grades 9-12
- Eligibility for the TDCAA and OFSAA is based on the athlete’s year of birth. An athlete is eligible to compete in high school sports for five years from the time they entered grade nine .

There is no appeal to this rule.

ELIGIBILITY / ACADEMICS

An athlete must be a bona fide student at their school.

Students With Less Than 22 Credits:

-non-semester schools – must be registered in a minimum of six (6) full day school credit courses.

-semester schools– must be registered in a minimum of three (3) full day credit courses in the semester that Field Hockey takes place (Fall).

Students With More Than 22 Credits:

-non-semester schools – must be registered in a minimum of four (4) full day school credit courses

-semester schools – must be registered in a minimum of two (2) full day credit courses in the semester that field hockey takes place (Fall).

LEAGUE STRUCTURE

- A) **START TIME** – All games shall begin no earlier than 3:30 unless agreed to by the Principals of the participating schools. All double headers must start no later than 2:30 or earlier if all participating schools are in agreement.
- B) **MAXIMUM NUMBER OF GAMES** - Junior – TBD; Senior TBD.
- C) **AWARDS** – In sports where there is less than six teams , only gold medals will be presented.
- D) **DEFAULTED GAME** – If a team defaults a regular season game , they will not be eligible for playoffs . A school may appeal the decision to the TDCAA Executive if there were extenuating circumstances.
- E) **CANCELLATION OF SCHOOL BUSES** – If the TCDSB cancels buses for weather conditions, all scheduled games are automatically cancelled

PART C: SPORT SPECIFIC INFORMATION

SECTION A

OFFICIAL RULES – SPORT GOVERNING

FOOTBALL RULES: EXCEPTIONS TO OFSAA AND CANADAIN AMATEUR FOOTBALL RULES

Competitions shall be governed by the official rules of the **Federation Rule Book/OFSAA** with the following **TDCAA/OFSAA** exceptions:

Unlimited Players: Teams must have all players on the team roster.

START OF THE SEASON

Practices may take place during the summer months. The following criteria must be followed if practices begin before the official start of school

- 1) Principal must be informed and approve
- 2) Each player must complete and submit the required permission forms before they are eligible to practice

KEY RULES

EACH ATHLETE MUST HAVE ACTIVELY PARTICIPATED IN AT LEAST EIGHT DAYS OF PRACTICE BEFORE PLAYING THEIR FIRST GAME. PRACTICES MUST INCLUDE SAFE TACKLING, BLOCKING, AND RUNNING IN EACH PRACTICE

THERE MUST BE A MINIMUM OF FOUR FULL DAYS BETWEEN ATHLETE PARTICIPATION IN ANY REGULATION FOOTBALL GAMES (eg between club competition and interschool completion or between interschool competition)

IN THE EVENT OF UNFORSEEN CIRCUMSTANCES (WEATHER ETC) MAKE-UP OR RESCHEDULED GAMES MUST BE SCHEDULED WITH A MINIMUM OF TWO FULL DAYS IN BETWEEN CANCELLED GAME AND RESCHEDULED GAME.

THERE MUST BE TWO FULL DAYS IN BETWEEN EACH TEAM'S PLAYOFF GAMES

PLEASE MAKE SURE THAT YOU ARE AWARE OF ANY ATHLETE WHO IS COMPETING IN CLUB FOOTBALL IN THE FALL.

OFFICIALS:

At least three certified officials must be present before a game can commence. In case of game cancellation, the officials shall be paid if they could not be notified in advance. The head official must sign the game sheet before it is sent to the convenor.

AWARDS

- Gold & Silver Medals
- Championship Pennant

● **ELIGIBILITY**

- All players must have dressed and appear on the game sheet at least one game to be eligible for playoffs
- A Junior player can play one game at the senior level without losing his/her Junior eligibility. When they play their second game at Senior, they become senior and cannot play any more games at Junior.
- A player who is registered on the senior team who is Junior age cannot play any games at the Junior level after your first league game even if he/she does not dress or play.
- A player can play in only one playoff series
- Once the TDCAA has declared a champion and a team advances to the OFSAA , junior players will be eligible to play.
- NOTE:
- A junior player cannot play a senior game on the same day as he plays a junior game

- There must be four full days between games for any athlete regardless of whether he/she plays a junior or senior game
- **COMMUNITY COACHES:**
- A community coach is a person who is not a teacher or member of the administration. Secretaries, custodians, and EA'S are considered community coaches.
- All community coaches must be registered with the school and completed all requirements as outlined by TCDSB.
- There must be a teacher coach on the bench at all times.

SCHEDULE – TEAM SPORTS

- Schedule will be developed by the convenor.
- A rough copy of the schedule shall be sent to coaches to check for conflicts. Coach and athletic director will have one week to sign off on their schedule.
- A final schedule will be sent to both athletic director and coach.
- Once the schedule has been finalized , there cannot be any changes except for starting times which must be approved by both teams. The site of the game may also be changed.
- A game which is called before its conclusion because of weather / bussing/ officials etc must be reviewed by TDCAA Executive Committee to determine the outcome
- Failure to play a game will result in forfeiture.
- Rescheduling: under these two conditions
 - i Weather or field conditions do not permit the game to be played
 - ii Official / therapist does not show up for the game

Length of Game:

All games consist of four quarters of 12 minutes each. If the game is tied at the end of regulation time, there will be overtime as outlined in the white book.

Defaulted Games: As per the TDCAA constitution. The win automatically awarded to the non-defaulting team. The score will be 5-0 awarded to the non-defaulting team. Any appeals related to the defaulted games must be made to Paul Solarski, Co-executive Director. The team who causes the default shall be responsible for all costs associated with game (referee's fee, field costs,...)

Making Changes to the League Schedule: Please contact the other coach/convenor via e-mail/phone to confirm the new date and time. The convenor will confirm the new date, location and referee.

LEAGUE TIE BREAKING PROCEDURES:

If two teams were tied for a playoff position , the game between the two teams will determine the playoff position

If more than two teams are tied for a playoff position , a point differential among the tied teams will be used to determine all playoff positions.

If three or four teams are still tied for the same playoff position, a point differential of all teams in the league will be used.

SCORE SHEET / ROSTER

- 1) Coach must submit a roster to the timekeeper prior to the game. Roster must include the names of all coaches on the sideline
- 2) At the conclusion of the game , each coach must sign the game sheet along with the head official
- 3) Game sheet along with rosters of both teams must be couriered or faxed to designated person within a week.
- 4) A fine will be assessed if game sheets are not received in this time frame

PLAYOFF FORMAT

The top four teams from each division will advance to the playoffs.

QUALIFYING FOR OFSAA

The team who wins the TDCAA Championship will represent TDCAA at OFSAA unless

- They have declared earlier that they will not be representing TDCAA
- Other

UNIFORMS / EQUIPMENT

UNIFORMS:

- 1) A player may not wear a tinted visor even with proper documentation
- 2) All equipment must be approved and certified
- 3) Home team should wear dark sweaters and visiting team light sweaters.

EQUIPMENT: The following is required for each play date:

- 1) Home team is responsible for providing goal post pads, corner markers, down box, & yard sticks
- 2) Home team is responsible for providing a timer and stick crew

INCLEMENT WEATHER

TDCAA football follows the steps as outlined in the amateur rule book.

PROTEST

If a team wishes to file a protest , they must do so in writing to the TDCAA Past President (Eva Roser – St. John Henry Newman) within 24 hours of the conclusion of the game. Protest fee is \$ 50.00

EJECTIONS

Any ejection from a game (player and/or coach) must be reported 1) your athletic director 2) convenor 3) and to the chair of discipline (Paul Solarksi – Brebeuf) by noon the day following the game. The chair will decide whether the player and /or coach must attend a disciplinary review meeting.

All ejections except _____ carry an automatic one game suspension.

MEDICAL:

TDCAA will provide a therapist for each game. A game may not be played without that therapist being in attendance even if there is a doctor or other certified personnel in attendance.

Schools will register their teams (Junior/Senior) no later than the coaches meeting

ENTRY FEES & ENTRY FORMS

- Official fees , therapist fees , permit fees (where applicable) will be paid directly by the TDCAA. Schools will be invoiced for these fees at the conclusion of the season.
- All players / coaches must be registered on the OFSAA Hub

MERCY RULE

- Based on the rule book , the clock will run when there is a point differential of 35 points starting in the second half of the game. When the point differential reaches 28 points at half time or the second half , the coach of the losing team can request the clock run for the remainder of the game.

REPORTING SCORES:

Both teams must complete the game sheet. Game sheets will be used to keep score. Both teams will notify the newspapers and the Convenor of the game results. The game sheet must be forwarded to the convenor. (fax/e-mail/interoffice).

Results of all games are to be reported by both teams to the following groups within 24 hours of the scheduled game:

When reporting score: to your convenor, to TDCAA web site and Peter Morris the following must be stated:

1. Sport Played
2. Date and Location of the Game
3. Junior or Senior
4. Home Team and Score
5. Visiting Team and Score

*You have until NOON the day following your game to report the scores to the three groups listed above. Peter will always acknowledge receipt of the e-mail

PENALTY- \$20.00 fine will be assessed both teams if the score is not reported.

- 1) Any player who is required to leave the field as a result of an injury must sit out three plays without exception.
